29 **OPENING PRAYER AND DECLARATION OF QUORUM**

30 The meeting was called to order at 4:02 p. m. CDT by moderator Leslie Yandle. The call for the
31 meeting was found to be in order: to examine Brian Yount, and if the way be clear, to approve
32 the terms of call to serve as Associate Pastor at Trinity Presbyterian of Pensacola. The request
33 was signed by two teaching elders (Mark Broadhead and Joan Wooten) and two ruling elders
34 (Joanne Kublik and Donald Mowat). **The docket was adopted.**

35 Danny Loffredo brought greetings from Gulf Breeze Presbyterian Church, introduced the
36 church's new youth director Lauren Christian, and offered an opening prayer. First-time elders
37 and other guests were introduced.

38 Mark Broadhead presented the initial report and recommendation of the Committee on Ministry:
39 that the Presbytery of Florida examine for ordination candidate Brian Yount. **The motion was**
40 **approved.**

41 Opening worship was held with Brian Yount preaching.

42 The Committee on Ministry report and recommendations continued following worship. Mark
43 Broadhead moved that the sermon portion be sustained; this was approved. Brian then shared a
44 bit about his personal story. Rev. Broadhead asked questions in the area of Bible, Theology,
45 Sacraments, Worship and Polity. There were additional questions in these areas from the floor.
46 Rev. Broadhead then moved that the exams in Bible, Theology, Worship and Sacraments, and
47 Polity be approved and that the exam be approved in whole. **The motion was approved.**


48 The Committee on Ministry recommends:
49 that Brian Campbell Yount be given permission to move on to the field and to work at Trinity
50 Presbyterian Church of Pensacola and be ordained as a Minister of Word and Sacrament and
51 installed as Associate Pastor at Trinity Presbyterian Church, Pensacola. **The motion was**
52 **approved.** Additionally, Rev. Broadhead moved that the proposed terms of call be approved as
53 presented in the docket. **The motion was approved.**
