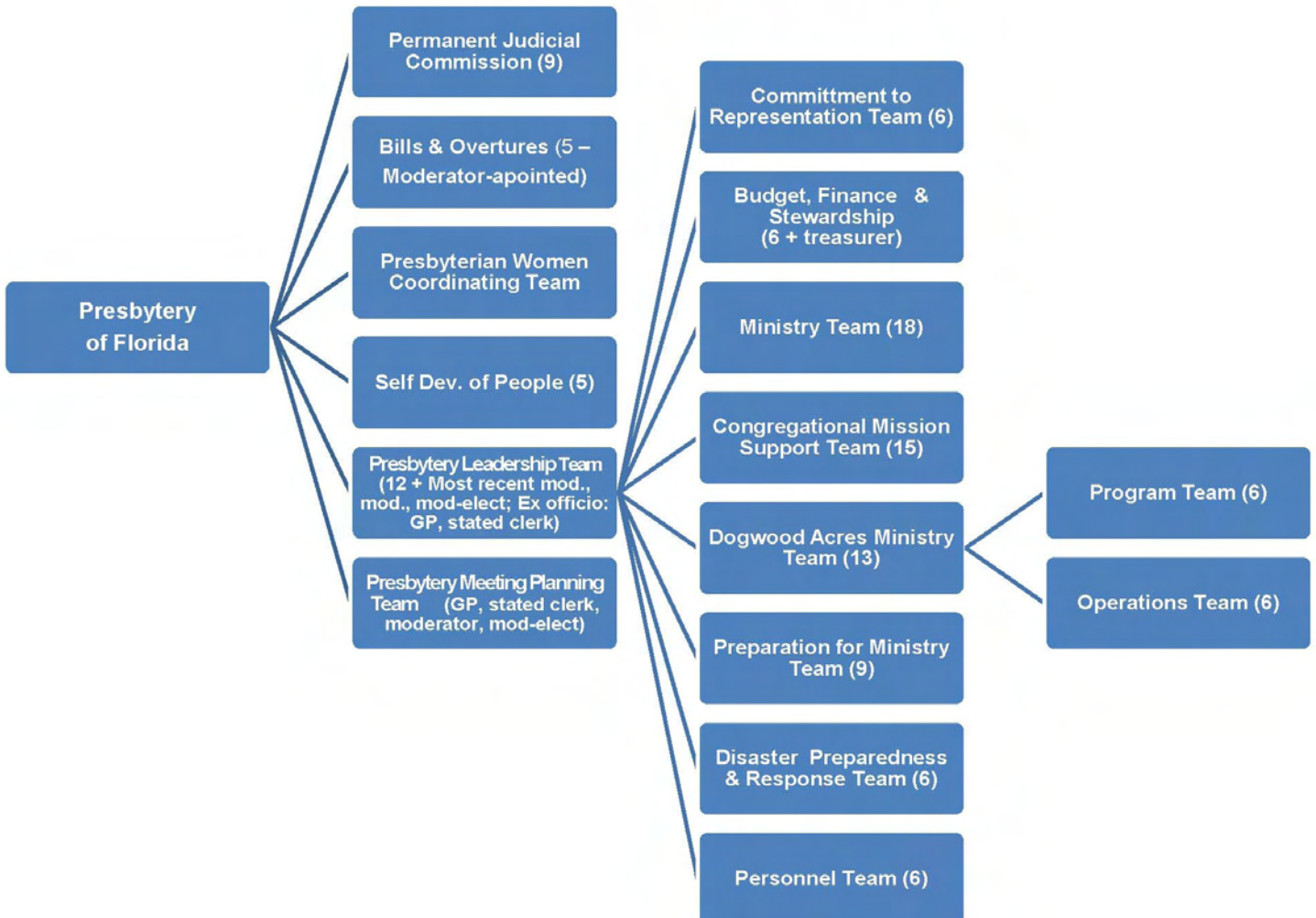

Stewardship of Creation Notes

Should we worry about the Keystone XL Pipeline?

Surely you have read about the proposed Keystone XL Pipeline, which will carry tar-sands oil from Alberta, Canada, to Texas. It is the most controversial environmental project in the United States, and the decision whether to proceed or not rests with President Obama.

February 17, 2013, the largest climate rally to date brought tens of thousands of people, from grandparents to students, to the front of the White House. Dozens purposely got arrested to make the point that this project should not be permitted. So, why are citizens willing to engage in civil disobedience, and should you worry about the pipeline?

This project would carry 700,000 barrels of tar-sands oil to Gulf Coast refineries, each and every day. If all the oil in these tar-sands is burned, the atmospheric concentration of carbon dioxide would increase from its current 390 parts per million to nearly 600 parts per million.

Our global average temperature has increased (so far) seem like very much, but with it, 2012 saw more than 34,000 U.S. heat records shattered. Violent western wildfires, widespread drought, record melting of Arctic ice and many devastating storms were all the consequences of a rise in global heat of less than 1 degree Celsius over the past 100 years.

This kind of weather, which is nowhere near as extreme as it will get with rising CO2 levels, threatens each of us and the

stability of our planet. And there are staggering costs associated with extreme weather. Just ask the Governor of New Jersey about the \$37 billion in damages from a single storm this winter. To read more about how our changing climate is already

Approval of the pipeline would slam the door shut on our ability to avoid the worsening impacts of climate change. It means that we are so addicted to fossil fuels we are willing to buy the dirtiest stuff on the planet. We will do anything to feed our addiction, regardless of the consequences even when we have other options. This has to be Increasing production of fossil fuels is *exactly the wrong thing* to do.

Stopping the pipeline will give us time to come to our senses about climate change and take steps to slow and reduce our rising carbon emissions. It will

signal that our leadership understands the irreversibility of climate change and is putting the welfare of people and the planet over short-term company profits. Yes, we will need fossil fuels to transition to alternative energy, but we need the cleanest fossil fuel (natural gas), not the dirtiest.

So maybe you should consider spending some prayer time lamenting how a single decision can have such a devastating effect on all of mankind and life on this planet. How being able to buy cheap gas for our cars and low electric bills to heat and cool our homes has become so important that we fail to see the damage we are causing all of creation. How we mindlessly endanger the wellbeing of our grandchildren and future generations. How we have gotten ourselves into such a perilous position.

Pray hard and maybe ask for a miracle, because we are going to need one if this project is approved. I pray that our President will stop our insane addiction to fossil fuels by not approving this pipeline. You could also write the President.
