He also will communicate the presbytery's interests to its churches, synod and General Assembly and will convey teaching and ruling elders'

and Christian educators' concerns to presbytery teams and other PC (USA) councils.

Pace shares good news

Pace is the place where progress is underway in the church's development and financial matters. After being approved for the Presbyterian Mission Agency's "For Such a Time as This" Program to match new seminary graduates with churches, Pace is now actively receiving Pastor Information Forms, or PIFs.

So far, 11 prospects have submitted PIFs, and the field has been narrowed to four, said Larry Plank, Commissioned Ruling Elder now serving the congregation. A congregation member contributed money to fund a pastoral-resident's full salary for Pace's two-year participation in the program, he said.

Additionally, with former Associate Executive Presbyter Jean Silva's help, Pace was able to stabilize its finances, he noted. Reworking its loan with the Presbyterian Investment Loan Program, or PILP, provided a drastic reduction in the church's monthly mortgage payments, he said. "PC(USA) is definitely willing to work with churches."

Meanwhile, the congregation is experiencing growth, as two new families have begun regularly attending worship and participating in the life of the church, Larry said. "The congregation is upbeat. It's given them a boost."

"For Such a Time as This" is designed to renew and grow small churches and help them to become healthy, missional congregations. The program pairs small, underserved congregations in rural, small town, and urban settings with recent seminary graduates in a two-year pastoral-residency relationship, during which they are supported and guided by a cluster of pastor-mentors. Since the program began in 2009, 22 recent seminary graduates are serving 26 congregations in 10 presbyteries.

A Scary Option in the Midst of Worsening Weather

You must have noticed that we are having more and more extreme weather and, in spite of predictions that it will get worse because of our warming planet, Congress continues to deny there is a problem, while at the same time paying more and more for weather-related cleanups. In fact, all of us are paying more.

Now there is an option for breaking the national grid lock of inaction – divest from the fossil fuel companies. Institutions from universities to churches are being asked to get rid of their investments in fossil fuels.

Last year was the hottest year on record, and Hurricane Sandy, fueled by Atlantic Ocean waters that were 5 degrees warmer than normal, caused over \$60 billion in destruction and left tens of thousands homeless. There was a devastating drought in the Midwest, and California and Colorado were on fire! May 31 of this year, a monster tornado with close to 295 mile per hour winds, 2.6 miles wide, hit Oklahoma.

There is this pesky thing behind this extreme weather – carbon dioxide emissions from our burning of fossil fuels. After more than two decades of warnings about the need to lower our carbon emissions, their atmospheric concentration is getting higher – dangerously higher, not lower. May 9th of this year, the global CO₂ concentration exceeded 400 parts per million, way above the safe level of 350 parts per million.

Fossil fuels have been an important part of civilization's advancement. They have provided a real social good that has been affordable and convenient. But now, with the proven connection between our changing climate and the burning of these fuels, the fossil fuel industry has become an obstructionist in

preventing us from moving to safe and renewable energy sources that preserve rather than destroy God's creation. Their very successful campaign to stop action to cut our carbon emissions has brought us to a very dangerous place.

Congress refuses to act. Our President is unable to act; all the while our weather gets worse and worse. Every year, more and more Americans suffer property damage. Damage costs are skyrocketing, and insurance companies are raising rates or refusing to insure property owners. Sea level is creeping ever higher, and future damage costs associated with storm surges, in combination with rising seas, are estimated in the trillions.

Talk about deficit being a problem. Think about climate change costs in the trillions.

In response to this, a very low key action begun on a college campus around 2008 has morphed into a campaign that is slowly gaining steam around the country – a campaign to get institutions to divest from fossil fuel companies. Bill McKibben and his organization 350.org are leading it. Their message is:

“If it is wrong to wreck the climate, then it is wrong to profit from that wreckage. We believe that educational and religious institutions, city and state governments, and other institutions that serve the public good should divest from fossil fuels. We want institutions to immediately freeze any new investment in fossil fuel companies, and divest from direct ownership and any commingled funds that include fossil fuel public equities and corporate bonds within 5 years.”

To date, five colleges are divesting from fossil fuels.

Divestment campaigns are underway at 308 colleges, 105 cities and states and with six different religions. Museums, hospitals, foundations and other organizations are divesting from fossil fuels.

To many investors, fossil fuels are an important part of their investment portfolio, and the idea of eliminating them is probably scary. However, a recent report from the Tellus Institute makes the case that a college or university could divest without sacrificing financial performance. Recently, the Associated Press came to the same conclusion, citing analysis by the research firm S&P Capital IQ that showed that by one measure, endowments would have been better off had they divested 10 years ago. Our denomination is one of the six considering divestment. Action for us begins in the pews, and two churches in California are thoughtfully and prayerfully considering this step.
